MICROPAS® tax credit version orders include the software, electronic versions of the user manual and other reference materials, and unlimited technical support while the license is valid. MICROPAS runs in all versions of Windows and requires at least 10mb of available disk space. Orders are usually shipped the same day the order is received via priority mail.

Unlike other versions of MICROPAS, the tax credit version requires the payment of a monthly license fee. Your license to use this version terminates when you stop paying the license fees.
